4. Wessex Water Proposal

Permission is requested from Wessex Water regarding a proposal to construct a small, below-ground pumping station, on the Village Green (please see attached proposed works location).

This initiative aims to provide relief from the sewer flooding that several properties in the local area are currently experiencing. The backing up of sewers in the area is a recurring issue, and the proposed new pumping station will provide extra storage capacity in the network to address this problem. Currently, to prevent internal and external flooding of the properties, a temporary above-ground overpumping setup needs to be erected within The Green and remain in place for several weeks during the winter months.

The properties affected by the sewer flooding issue are located next to a land known as 'Poulshot Green in the Parish of Poulshot, Wiltshire,' under register unit no. VG16 (please see the attached register supplied by Wiltshire Council). Given that the area covered by the Village Green covers this entire area, it would be challenging for Wessex Water to locate the pumping station and associated infrastructure elsewhere.

5. Allotment rent

Members are requested to note the increase of allotment rents from £20 per plot to £25 per plot as agreed in the budget for financial year 24-25 and that invoices will be sent to the tenants on the 1^{st} of October 2024.

37/24/25 Police Report

The attached Community Policing Team Report from March 2024 was noted.

38/24/25 Update from Wiltshire Councillor Tamara Reay

Cllr Reay reported on Wiltshire Councils £14m underspend and explained how £10m of this will be put to further Highways enhancement. Adding to previous new money investment and CIL contributions this will make £20.7m new spend over 2 years. There will be a focus on 'C' roads and unclassified roads, also black spots such as the Black Dog crossroads. Monies will also be put towards enhancements to Caen Hill. A further £1.7m will be issued towards flooding defences.

The Traveller site plan was also mentioned with Cllr Reay stating that the draft Gypsies and Travellers Development Plan Document was considered by Cabinet on 15 July 2024, and she would send through the link to the documents.

Concerns were raised by Members on the proposed location of two site within the local area these being 2 plots at Whistley Road, Potterne and 10 plots at Oxhouse Farm, Rowde.

Planning Working Group notes from the meeting on the 25th of June 2024 were further considered and noted. **40/24/25.2**

Village Survey Working Group

Cllr Bissett presented the notes from the Village Survey Working Group from the meeting on the 11th of June 2024. Cllr Dyke confirmed he would attempt to gain the required 3 quotes for a bus shelter, with Cllr Church confirming she is still trying to progress with the SID project but finding it increasing difficult with lack of response from the Police and Wiltshire Council to her numerous emails.

41/24/25 Grant Applications

41/25/25.1 Permanent Fencing of Allotments

Following the Grant Application from the tenants of the allotments where funding was requested to provide a permanent fence separating the parish allotments from the rest of Green Gardens. Although this application scored 17/21 and 19/21 respectively the application was discussed, with concerns being raised about the ownership and maintenance if the new fencing was approved. It was believed that maintence of the fencing around the allotments was already in the tenant's agreements and that the yearly rent was due to increase this year 24-25 to £25 per plot per annum. After further debate on ownership of the fence and installation; it was proposed by Cllr Bissett, seconded by Cllr Dyke and UNANIMOUSLY AGREED to refuse the grant application, but instead to use the CIL monies held by the Parish Council to purchase and install a post and rail fence with stock wire of approximately 28 meters using the existing gate as the access point; Cllr Dyke was given delegated authority to acquire 3 guotes and instruct the chosen contractor to provide and install the fence which must not exceed the CIL allocation 22/RV003.

41/24/25.2 Surplus Grant Monies

Following the issued grants of £ 500 for the D-Day and silent disco events, there was a surplus of just over £66. A request was made to put the surplus monies towards a cricket match/BBQ event for families of the village, being held on the 30th August 2024. It was explained that as per the Councils Policy all outstanding grant monies should be returned to the Council and not used for further unapproved events. It was therefore proposed by Cllr Bissett, seconded by Cllr Hues and UNANIMOUSLY AGREED to request the return of the surplus monies of just over £66. and to provide a one-off donation of £66. to Poulshot Friends and Neighbours Club including Peggies, to help with the funding of the planned cricket match/BBQ event on 30th August 2024.

Awarded under the General Power of Competence

42/24/25 Village Trust Update and Requests

Cllr Bissett read the update and members discussed the requests, with special mention of involving the Parish Council in the Keep Britain tidy event

due in spring 2025. It was therefore proposed by Cllr Church, seconded by Cllr Bissett and unanimously agreed to approve the following requests;-

- To continue to remove any existing Spanish Bluebells in Green Gardens next year.
- To permit a 'tidy-up' in Green Gardens in October, including the continued tackling of the hogweed.
- For the Parish Council to pay for the disposal of excess growth and New Zealand Pygmy Weed waste from the ponds on the Green, planned for November.
- For the Village Trust to lead on the installation of Plaques along the Queen's Platinum Jubilee Oak Walk on the 31st August. With the Chairman and Members of the Parish Council invited to attend along with Wiltshire Councillor Tamara Reay.
- For the support and involvement of the Parish Council on the Keep Britain Tidy campaign, due in spring 2025.


