5. Notice from Ashford Homes and Request from SSEN

We have been working with SSE to connect a temporary electric supply for the duration of the build given that the existing supply was disconnected back in 2018. SSE proposes to bring a connection down from the pole to right of the access to a meter box, from which we will run a cable into site as shown on the attached plan. This will of course avoid the need to run a generator for the duration of the build which we are keen to do to minimise disruption for surrounding residents.

SSEN have received a request for a new connection at Higher Green Farm, Poulshot Road, Devizes, Wiltshire, SN10 1RW. WSP are working on their behalf to obtain the necessary consents needed for the work.

In order to progress the request, we need wayleave consent as the works are on private land owned by the Parish (title: WT280090).
