8. Naming Suggestions for The Higher Green Farm Development

The following suggestions have been received for the naming of the residential development. Councillors are asked to consider and agree their favoured name before advising the development contractor.

- a. "The most obvious name is probably 'Higher Green Farm Close' which is fine. Could I suggest 'Nixon Close' as one alternative? Malcolm Nixon farmed there for many years and was active around the village in many areas, including long service as a parish councillor. He was also very popular."
- b. "My suggestion is RAVEN CLOSE, the simple reason is it is opposite the Raven Pub. When asked where I live and I say Poulshot, their reply is "oh you have The Raven Pub". Poulshot is well known far and wide as the village with the lovely pub. Also, to give directions to anywhere in the village, can be difficult because of the strange way the house numbers have been used. What an easy way to give directions to a new development than to say opposite The Raven".
- **c.** "I would like to suggest that one of the roads in the new Higher Green Farm development be named "Nixon Close" or "Nixon Way" etc. to commemorate Malcolm Nixon who used to farm that area. Either that, or something farming related please."

d. "I've been thinking about possible street names for the new homes being built.

I have two suggestions both are to acknowledge personal contributions to the village. Maybe their names/part of their names could be used.

Geoff Collett whose family were born here and as we all know Geoff has always been very involved in the village/parish council. The other is Mike Hues who was on the parish council for 40 years or so and has also always had the best intentions for the village."

11. Defibrillators

a. The three defibrillator schemes in Poulshot are due for renewal in February 2023. If renew is to go ahead, the total cost for the three devices will be as follows:-

First full scheme £1800 plus VAT

2 x additional schemes £2000 plus VAT

Total £3800 plus VAT

The cabinet and defibrillator at The Raven is due for replacement in February. Council will need to cover the cost of removing the old and installing the new cabinet. Currently there is a global shortage of defibrillators so it may mean having to leave the current device and cabinet in situ until back orders of defibrillators are received.

If a decision is made not to renew, the equipment will be retrieved on or soon after 24th February.

12. Community Fund Grant Request- Attached

The following grant application was deferred from the meeting on 15th November 2022

The cricket club have had advice confirming the pitch (artificial strip) needs some servicing / maintenance. They have received prices from the original installer (excessively expensive at c£1200) and an alternative for £680. Having spoken to both and reviewed within the Club they have provisionally booked in with latter, however they are requesting help to fund this project.

All proceeds will be donated to The Freewheelers EVS (Blood Bikes) which we all think is a very worthy cause."
